

INDEMNITY

POLICY NUMBER: _____ **(THE "POLICY")**

1. We acknowledge that the Policy was effected under Section 73 of the Conveyancing and Law of Property Act and an irrevocable statutory trust was created in favour of the Beneficiary because the policyowner nominated his/her spouse and/or child(ren) as beneficiary(ies).
2. We hereby instruct Manulife (Singapore) Pte Ltd (the "**Company**") to revoke the statutory trust created in respect of the Policy (the "**Instructions**").
3. In consideration of the Company acting in accordance with the Instructions, I hereby agree to indemnify and hold harmless the Company from and against all demands, claims, actions, damages, suits, proceedings, assessments, judgments, costs and legal and other expenses as a result of the Company acting strictly in accordance with the Instructions.
4. This INDEMNITY is governed by, and construed in accordance with, the laws of the Republic of Singapore. A person who is not a party to this INDEMNITY shall have no right under the Contracts (Rights of Third Parties) Cap. 53B to enforce any of its terms. No consent from any person who is not a party to this INDEMNITY is required for any termination or variation of this INDEMNITY.

This indemnity has to be signed by the following persons:

- a) **the beneficiary. If there is more than 1 beneficiary, all the beneficiaries must sign;**
- b) **the trustee. If there is more than 1 trustee, all the trustees must sign; and**
- c) **the policyowner.**

The witness has to be at least 21 years old.

If the beneficiary is:

- (i) **at least 18 years old but below 21 years old, both the parent/guardian (who is not the policyowner) and beneficiary must sign;**
- (ii) **less than 18 years old, the parent/guardian (who is not the policyowner) can sign on behalf of the beneficiary.**

Photocopy(ies) of NRIC/PP/BC of Beneficiary(ies) and Trustee(s) should be submitted with this form.
